**LETTER OF REQUEST TO ;
CONOVER BOARD OF SUPERVISORS**

Please accept this letter as a written follow up to my phone request today to Conover Clerk , Kathy Mitchell , to be on the Agenda of the 12/04/14 Conover Town Board Meeting at which Landover ATV Club (LATVC) will request the Town of Conover pass an Ordinance allowing All Terrain Vehicle / Utility Task Vehicle (A T V /UTV) travel on Conover Town Roads. LATVC requests that all Conover roads be designated as ATV/UTV Routes , as well as County Highway K East , from Town Road east to Grapes Twin Haven . This will allow ATV/UTV travel between Conover residents and all Conover Business. Certain Conover roads and Vilas County Forest Trails will be designated and signed as ATV/UTV PREFERED ROUTES . (see maps attached) These PREFERED ROUTES will handle most all Conover travel going to and from Eagle River/Town of Lincoln ;Town of Phelps; and Town of Land O Lakes . A designated Park and Ride at Burnt Bridge parking lot will provide access from Town of Plum Lake and west .

WI ATV ASSOCIATION (WATVA) recently recommended this PREFERED ROUTE designation as a way to allow residents to get to the closest trail by road, similar to the "snowmobile access law." The PREFERED ROUTE signing and mapping will become familiar with riders from other parts of the state.

The roads designated as PREFERED ROUTE are as follows ;

- Deep Lake Rd , from Town of Lincoln line to Vilas Forest Snowmobile trail #13
- East Buckatabon Rd , from Buckatabon Game Trail north to Snowmobile trail #13
- County Highway K (and R O W) from Burnt Bridge Park & Ride to Denton Rd
- County Highway S from HWY. K to Heart Lake Game Trail
- Town Rd from HWY. K to HWY. 45
- Muskrat Creek Rd. from HWY K To Snowmobile Trail Junction #8 & #45 (JUST NORTH OF THE Muskrat Creek)
- Firelane Rd from Snowmobile trail #8 to Old 45 Rd .
- Old 45 Rd HWY. 45 to HWY. 45
- Rummels Rd from RR grade to Snowmobile trail #13

**LANDOVER ATV CLUB AGREES ON FOLLOWING OPERATING STANDARDS /
RULES WHICH ARE CONSISTENT WITH THE TOWN OF PHELPS ORDINANCE :**

- Will raise the necessary funding to install , inspect and maintain signage and trails
- The routes will be open May 1 to Oct.31
- Will provide WATVA trained Trail Patrol Ambassadors to patrol trails /routes
- Speed Limit on all roads will be posted limit, not to exceed 35 mph . Operators will slow to 10mph or less when operating within 150 feet of a dwelling and within 100 feet of a pedestrian.
- Operation shall be to the right side of the pavement , single file

- These rules of operation shall be printed on Club maps which will be made available for sale distribution.
- Conover will be named as co-insured with Vilas County and other Townships.

Thank you for your consideration on this matter. Landover ATV Club was started May 2001. The name Landover came from Land o Lakes & Conover. It would be great if we could celebrate May 2015 connecting these communities with an ATV/UTV trail. It would help "kickstart" the summer for the Business Community! We would have a lot of work to make this happen (fund raising, trail signing, map development, and event planning) so it is important we get approval, an ordinance, at the earliest possible date.




