## Plat or Drawing Requirement (use separate sheet PLEASE)

Attach a sketch or plat drawing of the project which includes the following:

1. location of existing buildings, well, septic, sheds, garages, driveway etc. etc.
2. distances of new construction from the center of the public roadway
3. distances of new construction from the high water mark of any lake, river or stream
4. distances of new construction from side and rear lot lines
5. approximate lot size dimensions
6. indication of direction (North, South, East & West)
7. indication of dimensions of each item being constructed  
(Example) 10 x 12 deck, 43 x 28 garage, 50 x 30 home

### NOTICE:

New construction on undeveloped lots will require a "Driveway" permit which allows for the excavation near road right-of-way. Diggers Hotline must be notified and permit must be obtained from the Conover Zoning Administrator. A fire number Application is needed when construction has started on site and the cost of the sign plus the post will be billed to the property owner in accordance with Town's Local Ordinance at cost.

When applying for a DEMOLITION permit, you must provide proof of utility DISCONNECTION at time of permit application. Utilities (Electric) must be disconnected in conjunction with the request for demolition. The request line for disconnection is: 262-574-6452 or toll free to 866-423-0364 (We Energies).
